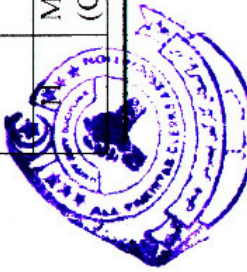
NOTIFICATION
