# **NOTIFICATION**

NO.FD(SR-III)3-2962/2025:- In exercise of the powers conferred by section 26 of the Sindh Civil Servants Act, 1973, the Government of Sindh are pleased to make the following amendment in the West Pakistan Civil Services Pension Rules, 1963, with immediate effect:-

#### **AMENDMENT**

In CHAPTER III, in rule 3.5, for clause (i), the following shall be substituted:-

"(i) opts to retire after twenty-five years of qualifying service or attaining the age of fifty-five years, whichever is later; provided that the reduction factor indicated in the table below shall be applicable in case of voluntary retirement.

### **TABLE**

Reduction Factor by Age of Voluntary Retirement	
59 years	2%
58 years	4%
57 years	6%
56 years	8%
55 years	10%
