NOTIFICATION

In accordance with the decisions taken by the members/representatives of **APCA Pakistan (Shaheed Saqi), Sindh, and the employees of Karachi Division**, in the meeting held on **17 August 2026**, under the chairmanship of the **Provincial President, APCA Pakistan (Shaheed Saqi), Sindh**, and with the approval of the **Central Chairman / Central Leadership** and the consent of the **Provincial Leadership of APCA Pakistan (Shaheed Saqi), Sindh**, the following **Executive Divisional Body of APCA Pakistan (Shaheed Saqi), Karachi Division** is hereby constituted and notified.

The Executive Divisional Body shall represent and work for the legitimate interests, welfare, dignity, rights and professional development of employees/officials serving in **Federal and Provincial Government Departments, Autonomous Bodies and Educational Institutions** within Karachi Division, particularly employees in **BS-01 to BS-16** and officers in **BS-17 to BS-19**, as applicable under the organization's constitution and Bye-Laws. This notification is issued in the **best interests of employees and for strengthening the organizational structure of APCA Pakistan (Shaheed Saqi) in Karachi Division**.

Tenure

The tenure of the Executive Divisional Body shall be **three (03) years**, commencing from the date of this notification and remaining valid **up to 31 December 2029**, unless otherwise amended, extended or superseded in accordance with the Constitution/Bye-Laws of All Pakistan Clerks, Pensioners & Civil Employees Association /APCA Pakistan (Shaheed Saqi).

Upon expiry or cessation of the authorized tenure, no office bearer/delegate shall be entitled to represent himself/herself as an authorized representative or office bearer of **APCA Pakistan (Shaheed Saqi), Karachi Division**, unless duly reappointed, elected or otherwise authorized by the competent organizational authority.
