Consequent upon the receiving recommendation of the Election Committee for nomination of Provincial Executive Body, APCA Pakistan (Shaheed Saqi) Punjab & with the approval of Mr. Zulfiqar Ali Shaikh, Central Chairman, APCA (Shaheed Saqi) Pakistan, in exercise of powers vested in him under Chapter-III Article-10 (a) & (b) of APCA Constitution / Bye-laws 2011 (Amended), the Provincial Executive Body, All Pakistan Clerks Association (Shaheed Saqi) Pakistan, Punjab Province is hereby notified consisting upon the following persons as office bearers by waving of Article- 36 (b) (c) in the best interest of employees/officials Grade 1 to 16-17/18 of the Government Institutions / Offices/ Departments of Provincial, Federal as well as Autonomous Body in Punjab Province until further orders and unless completed their tenure up to 31-12-2024 repeated 31-12-2024.
